


I Class 2024 Student Profile



Two Intakes: Accelerated vs Regular Pathway



Other Costs

The cost of living in Singapore may vary depending on lifestyle and accommodation. In general, the average monthly budget for international students at SMU stays within \$\$2,500. The following is an estimate of basic living costs :
